Notable for Fiscal Year 2022

In FY2021, Via's leadership team worked diligently to keep the agency financially stable so it could rebuild as the COVID-19 pandemic continued. In addition to applying for and receiving federal, state, local and private funding, Via closed its last Thrift store and ended hosting two special events so that staff could concentrate on Via's core mission and build back to pre-COVID service levels.

During FY 2022, Via leadership and staff continued efforts to get the agency back to pre-COVID service delivery numbers. At the beginning of fiscal year 2022, Via was at 81% of pre-Covid service levels; at the end of fiscal year 2022, Via was at 91% of pre-Covid service levels. With the elimination of the thrift stores and a commitment to the efficient use of administrative support, Via has grown services since 2020 while reducing administrative employees by 19%.

In addition to getting back to pre-Covid service levels, Via employed several initiatives to increase employee retention rates, including employee forums, bonuses and wage increases, employee raffles and more. Using a rolling 12-month measurement, the turnover rate during FY 2022 was 30.9%. This compares favorably to previous fiscal years: 57% FY2018; 52% FY 2019; 50%FY2020; and 41% FY2021.
